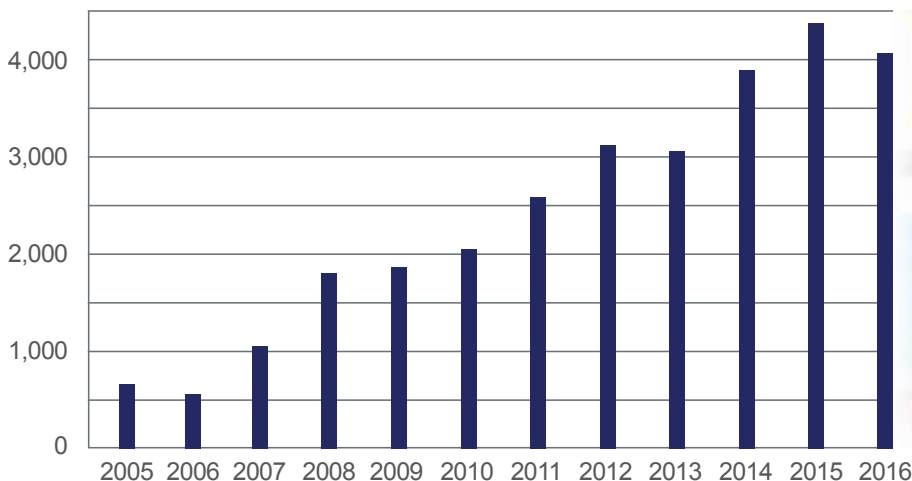

NUMBER OF ENDOW IOWA GIFTS YEAR OVER YEAR:

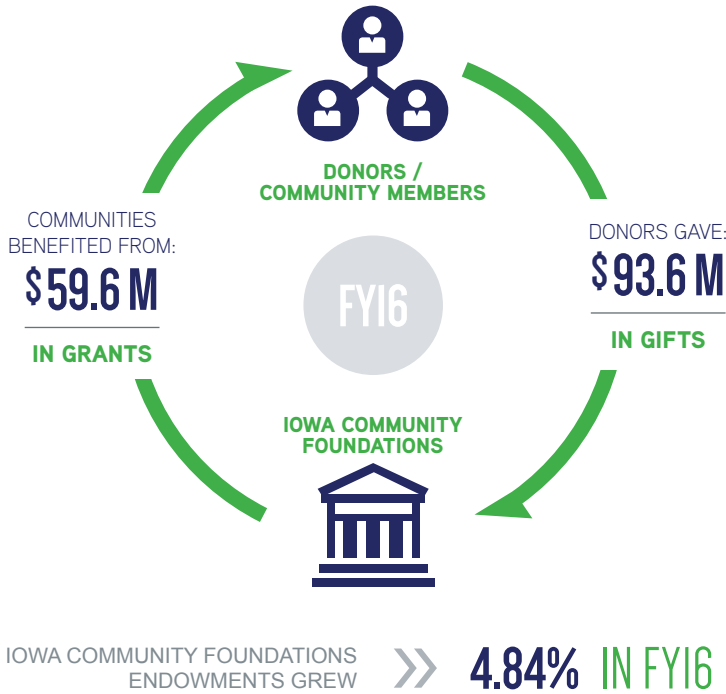
